**General Information:** This guide gives course selection information for an agreement between CCP and Alvernia College. The agreement states that a student who earns an AAS in Justice from CCP transfers with third-year status to Alvernia's Criminal Justice program. Students must earn a grade of "C" or better for courses to transfer. Alvernia courses are offered in Elkins Park, Montgomery County. **Note: This guide is based on CCP degree requirements for students who entered the Justice curriculum through summer 2009. Students who enter the curriculum fall 2009 or after should consult Justice curriculum advisors about curriculum changes.**
