General Information: The following is an agreement between Community College of Philadelphia and Philadelphia University’s Office of Continuing & Professional Studies’ Accelerated Bachelor of Science Degree Completion Program. Students who complete any associate degree at CCP and complete the courses listed below, as a part of that degree, are eligible for guaranteed third year (Junior) status in Philadelphia University’s Continuing & Professional Studies Accelerated Degree Completion Program. Six concentrations exist within the B.S. degree program, of which Pre-MBA is one (please see the five other guideline sheets). Other eligibility requirements are as follows: students must have a final GPA of 2.0; students must follow all schedules for the payment of fees and other registration procedures that apply to all students at Philadelphia U.; and enrollment at Philadelphia U. must occur within three years after CCP graduation. Also, Philadelphia U. will accept no more than two courses in which “D” grades are earned. Participating students will receive a scholarship of 25% of tuition per credit if they complete the associate degree with a GPA, at graduation, of 3.5 - 4.0. CCP students who graduate with a GPA of 3.0 – 3.49 will be granted a scholarship of 20% per credit. Scholarships will be renewed each year if the student maintains a 3.0 GPA at Philadelphia U. In transfer to Philadelphia U. up to 72 credits can be applied to the bachelor of science degree (see free electives/minor concentration below).
