Dear Candidate,

The CDCA-WREB-CITA, **Simulated Patient Treatment Clinical Exam (SPTCE)** will be given at Community College of Philadelphia on **Wednesday and Thursday, June 28 and 29, 2023.**

For directions to the College please go to [www.ccp.edu](http://www.ccp.edu). Community College of Philadelphia offers \$6 parking in the lot between Callowhill and Spring Garden Streets. Entry is off of either 17<sup>th</sup> or 18<sup>th</sup> streets. There is also street parking at meters for 4 hours or a private lot in the Museum Towers located on 18<sup>th</sup> street between Callowhill and Spring Garden Streets. The Double Tree Hotel which is located on Broad and Locust Streets would be a convenient place to stay.

You will **need to bring** the following items the day of the SPTCE (Simulated Patient Treatment Clinical Examination):

- PPE: Gloves, masks, gowns, face shield and protective eye wear for yourself
- Barriers, Caviwipes or Birex
- Two sets of sterile instruments: sterilization will also be available after examination
- Your **own** Ultrasonic tips (**30K**). You **cannot** bring your personal ultrasonic unit because the clinic does not have the quick disconnect for the water line, please bring the appropriate ultrasonic tip mentioned

**In addition to registration with CDCA-WREB-CITA, you must also register with CCP. There is a facility fee of \$275.00 to take the exam at CCP, which must be paid at the time of registration with CCP.** To register with the college and secure your place for the examination, complete the exam registration form and return with payment by **June 7, 2023** or **register online at [www.ccp.edu/professional](http://www.ccp.edu/professional)** . Go to the Health and Wellness Heading and select Simulated Patient Treatment Clinical Exam (SPTCE) to view exam times and to register. Payment must be made at the time of registration.

CDCA-WREB-CITA will send you information on your assigned session and you should use the following information when registering with CCP for The Simulated Patient Treatment Clinical Examination:

**HEAL D0011 Section: 009 (Open to non-CCP students)**

**06/29/23 – Mid-Morning session: 10:30 a.m. to 2 p.m.**

**HEAL D0011 Section: 010 (Open to non-CCP students)**

Please be sure to view the online orientation materials prior to the examination. On exam day there will be a short registration immediately before the exam. At this registration, IDs will be checked and exam forms will be handed out.

Our clinic may be quite chilly. You may want to dress in layers wearing your scrubs the day of the examination.
