Essay requirements - The essay should be typed, 12-point font, double-spaced, and a minimum of 250 words. The following topics should be discussed:

- Discuss your future goals and how you believe the program will enhance your ability to meet those goals.
- Discuss any prior educational or professional challenges and/or successes.
- Discuss how you plan to be academically successful in an accelerated course environment.

***Note – The essay requirement is waived for any applicant who achieved a 3.0 or higher high school GPA.**

_____ 6. Have an interview scheduled. Once we receive the required documents and review your placement test results, we will contact you for an in-person interview (if requirements are met). You will be contacted to interview with the Business-Accelerated Coordinator and/or the Business Administration Department Head.

_____ 7. If you are accepted into the program, you must complete the following tasks before your admission is complete:

- Sign the Commitment Statement, alerting the BUSX Program Coordinator that you know and agree to the requirements for the program.
- Participate in Summer workshops that will prepare you for the Fall 2025 program start.
- Change your academic major back to Business-Accelerated.

Due to the competitive nature of the Business – Accelerated program, there are special admissions requirements applicants must satisfy to be considered for admission.
